

# Kenya at Crossroads

Coming just a day after the Azimio la Umoja announced the suspension of their weekly protests, which were set to continue on Wednesday, July 26.

Speaking in Elgeyo Marakwet County, the CS said it was due to how the police service properly dealt with protesters last week that this week's protests were called off.

The Interior Cabinet secretary said the government **will deploy the same force** they have applied to terrorists and bandits on demonstrators.

Most hospitals in affected areas have been ordered not to report victims of gunshot wounds.

Mr Ruto has BANNED peaceful demonstrations in the country.

He has not issued a decree to BAN them, but he has used police TERROR to, for all practical purposes, outlaw peaceful demos (contrary to Article 37 of Kenya constitution).

## President William Ruto predicts maandamano will 'stop like reggae'
