

## US Secretary of State Anthony Blinken's Connection to Mossad

US Secretary of State Anthony Blinken's connection to Mossad is not just familial – It is much, much deeper.

1. Anthony Blinken was brought up by step-father **Samuel Pizar**.
2. Pizar was lawyer/*consigliere* (chief adviser) to **Robert Maxwell**, prominent Mossad agent/tycoon.
3. Robert recruited **Jeffrey Epstein** into Mossad.
4. Robert's daughter **Ghislaine Maxwell** was 'madam'/ally of Epstein.
5. Ghislaine & Epstein manipulated children to engage in s.exual acts with prominent politicians, businessmen etc – all secretly recorded, for future blackmail by Mossad.



Until this week the YIVO Institute for Jewish Research, the leading repository of information on Eastern European Jewry, was planning its annual benefit dinner as a festive tribute to the publisher Robert Maxwell and his wife, ELISABETH MAXWELL. But Mr. Maxwell's death on Tuesday has transformed the occasion into "a solemn celebration" of Mr. Maxwell's life and his commitment to Jewish history and culture, said ROSALINE SCHWARTZ, a spokeswoman for the institute in Manhattan.

Ms. Schwartz said the institute's staff "is still in a state of shock" over Mr. Maxwell's sudden death at sea. But she said the organization's board met late Tuesday and decided to go ahead with the benefit dinner on Nov. 24. Ms. Schwartz said no one knew yet whether Mrs. Maxwell, who has been as active in Jewish causes as her husband and was also to be honored, would attend. The board has sent condolences, but has not tried to talk with the Maxwell family, she said.

SAMUEL PISAR, a Holocaust survivor and lawyer who was a close friend of the Maxwells, will deliver a eulogy of Mr. Maxwell at the dinner, Ms. Schwartz said. She said an exhibit at the benefit about Mr. Maxwell's early life in Czechoslovakia would be expanded, too.

*Democracy Dies in Darkness*

TENERIFE, CANARY ISLANDS, NOV. 8 -- Lawyers for the family of British publisher Robert Maxwell today called the initial findings of a Spanish autopsy insufficient and said they will investigate the circumstances of Maxwell's death, including the possibilities of foul play or an accident.

"Every avenue will be explored . . . all hypotheses are being considered," said Paris-based attorney Samuel Pisar. When asked if this included murder, Pisar responded, "I assume everything."

The preliminary results of an autopsy on Maxwell, who apparently fell overboard from his luxury yacht before dawn Tuesday, attributed his death to heart and lung failure. A Spanish judge overseeing the case, Luis Gutierrez Sanjuan, said the results point "to a natural death before

Epstein was introduced to the spy game by Ghislaine's father Robert, according to Mossad agent Ben-Menashe who claims to have been the British media tycoon's 'handler.'

A friend of the Maxwells, Laura Goldman, further stated **she believed not only that Robert Maxwell was a Mossad spy**, but that Ghislaine carried on his work.

Journalist Julie K Brown, who broke the Epstein case for the Miami Herald, pointed out the eerie similarities between the deaths of both Epstein and Maxwell.

Epstein, 66, was found dead in his prison cell at New York's Metropolitan Correctional Center, in 2019 after an apparent suicide while awaiting trial for his crimes. But rumors continue to swirl around exactly what happened.

According to one prominent Jewish journalist, "Blinken has said he's **inherited** his commitment to Israel's strength..." (attached graphic)

He adds, "**the last phone call that Robert Maxwell made** before he mysteriously fell off his yacht **was to Samuel Pizar** (Blinken's step-dad)"

## **Deep state connections**

Blumenthal's explosive dissection of Israeli influence over the U.S. government does not stop there. He cites deep state connections between the chief diplomat of the U.S. and the Israeli intelligence agency, Mossad.

"Tony Blinken – the U.S. Secretary of State – is in Israel right now participating in their war cabinet meetings," Blumenthal says, noting that Blinken "is a member of the Israel lobby – but he's supposed to be our chief diplomat. He's not putting America first here. He's not able to."

Pointing out the nebulous intentions of the U.S. Secretary of State, Blumenthal goes on to explain the startling family connections of the most senior diplomat in the USA.

"It's unclear what he's putting first but his grandfather actually started a think-tank in the 1930s to lobby for the Zionist movement in Palestine."

"So Tony Blinken is supposed to preside over a resolution to this conflict with all these passionate attachments and familial ties? He said that he's inherited his commitment to Israel's strength and I think what we want in a diplomat is someone who looks at – balances – all sides and tries to come to a peaceful resolution."

Instead, Blumenthal says, "...but what you have here is someone who seems to take everything personally."

These personal ties and inherited grievances, Blumenthal argues, cast doubt on Blinken's suitability for any role in negotiating with Russia as well.

"[Blinken's] also said 'I have family from Ukraine – that's why I support Ukraine.'"

"This is the opposite of diplomacy. This is so dangerous right now. We have all of the ingredients for World War III because we're not thinking rationally, we're not looking at history and we refuse to look at the needs of both sides," Blumenthal states.

**NOTE:** Anthony Blinken is not an ordinary Cabinet Secretary – He is the *de facto* President of the United States.

This means that, Israel is ruling the USA through Blinken.

Unsurprisingly, Israeli government commits the most egregious crimes – e.g. IDF genocide in Gaza; Mossad international terrorism – because they know they have American government in their pocket.

Israeli PM and his government know that, if any resolution to force them to obey international law is taken to the United Nations, USA will always veto it.
